SHORT TENDER NOTICE NO. 98 OF 2020-21 of GM, LTPS

Sealed tenders are hereby invited from the reputed Contractor/Firms/Suppliers having sufficient financial capability and experiences for **Rate Contract** for 01 (one) year for supply of following Chemicals, by the General Manager, Lakwa thermal Power Station, APGCL, Maibella.

1. Scope of Supply of Chemical:

2. Cost of Tender Paper (Non refundable): One set of Biding document (Short Tender Notice) will be issued from the office of the General Manager, LTPS, APGCL to intending bidder on submission of Rs. 500/- (Rupees Five Hundred only) in the shape of Bank Draft duly pledged in favour of the **Asstt. General Manager (F&A), LTPS, APGCL, Maibella**. The Tender document may also be downloaded from the APGCL's website (www.apgcl.org) in which case the Tender fee has to be submitted along with the Bid in the shape of Bank Draft duly pledged in favour of the **Asstt. General Manager (F&A), LTPS, APGCL, Maibella**.
3. Earnest Money Deposit (EMD) (Refundable): EMD @2% of the total quoted value (for 10 MT quantity) in the shape of Bank Draft of any Scheduled Bank duly pledged in favour of the **Asstt. General Manager (F&A), LTPS, APGCL, Maibella**. APGCL will refund the Earnest Money of the unsuccessful bidders directly to the bidders within a reasonable period of time without any interest on received of written request. The EMD of the successful bidder shall be returned after end of contract period.
4. Eligibility of bidder:
 - (i) The bidder should have experiences of supplying different types of chemicals.
 - (ii) Bidder must have financial capability of supplying such items and sufficient credentials shall have to be furnished.
 - (iii) At least one such supply order amounting to Rs. 1.00 Lakh minimum in last 3 years shall have to be furnished.
5. Payment: 100% payment including all taxes & duties shall be made after delivery of the material in good and in full quantity and acceptance of the same by concerned personnel of LTPS. The bidder shall submit the bill in quadruplicate for payment.
6. Quality: The material to be supplied as per specification. The material shall be tested at the time of delivery and in case of failure in the test, entire material will be rejected and fresh material to be supplied.
7. Rate: The rate to be firm and delivery at LTPS basis.
8. Loading & Unloading: The loading & unloading will be in bidder's scope. Interested bidder may visit site for viewing unloading facilities.
9. Tax: Tax to be shown separately.

10. Delivery: Delivery to be within 30 (thirty) days from the date of issue of the purchase order. The material shall be delivered at LTPS site.

11. The rate contract will be for one year.

12. Liquidated Damage: In case of delay in supply of ordered materials beyond the delivery period as mentioned in clause '10', a penalty @1% (one percent) of the total order value (including all taxes & duties) per week or part thereof delay, subjected to maximum of 10% (ten percent) of the total value will be imposed upon the supplier. However, the payment of Liquidated Damage shall not in any way relieve the supplier from any of its obligation to complete the delivery or from any other obligation and liabilities of the supplier under the Contract.

13. Mandatory documents: The bidder must furnish the following mentioned documents along with the technical part of the submitted tender without which the submitted tender may not be considered for evaluation at this end:

- Signed & sealed copy of LTPS, APGCL Tender Document (Short Tender Notice) with filled in quoted price.
- Copy of PAN Card.
- Copy of valid GST Registration Certificate of the bidder's Firm.
- Documents related to bidder's eligibility and past experience.
