Supply of 3.3 KV, 400 mm², Three core, XLPE insulated, Armoured, Aluminium Cable and Cold Shrinkable Indoor Termination Kit for LTPS, APGCL, Maibella.

(A) OBJECTIVE:

Lakwa Thermal Power Station (LTPS) and Lakwa Replacement Power Project (LRPP) are two natural gas based Power generating Station located at Maibella under Charaideo district, Asam. LTPS consisting of two power houses (Ph-II & Ph-III) with total installed capacity of 97.2 MW. LRPP consisting of 07 nos. of Gas Engines with total installed capacity of 70 MW. All the Gas, Steam Turbines and Engines are run in synchronization with the National Grid. The Phase-II Power House of LTPS has 03 nos. of GE/BHEL make Frame 5 Gas Turbine Units: Model MS 5001. The Phase-III Power House of LTPS has 01 no. of BHEL make Stream Turbine Unit which uses waste heat of GE/BHEL make Gas Turbines as fuel. The LRPP has 07 nos. of Wartsila India Pvt. Ltd and Wartsila Finland make Gas Engine of 10 MW each. The fuel, i.e., Natural Gas, for the gas turbine and Gas Engines units is compressed to required pressures by using Gas Compressors. Presently, it is intended to procure 1) 3.3 KV, 400 mm2, Three core, XLPE insulated, Armoured, Aluminum Cable and 2) Cold Shrinkable Indoor Termination Kit for PH-II power House of LTPS, APGCL, Maibella. The Cable and termination kits are required for 3.3 KV Gas Compressor (GC) driving motor of GC#6.

(B) INTENT OF THE TENDER DOCUMENT:

The intent of this tender document is to furnish work scope, i.e., supply of 1) 3.3 KV, 400 mm2, Three core, XLPE insulated, Armoured, Aluminum Cable and 2) Cold Shrinkable Indoor Termination Kit as well as other technical and commercial requirements to be furnished or fulfilled by the bidder participating in the tender.

(C) ELIGIBITY OF BIDDER:

The bidder must be a Manufacturer or Manufacturer's Authorized Supplier of power cables and Termination Kit (3.3 KV or above). In case of authorized supplier of cable and Termination Kit, necessary authorization certificate from Manufacturer must be furnished with technical part of the submitted bid, without which the bidder may not be considered eligible for this tender.

(D) EXPERIENCE OF BIDDER:

The eligible bidder must have sufficient experience in successfully supplying of power cables (3.3 KV or above and suitable Termination Kit). Documentary evidence in regards to past experience (e.g., copies of Work Order/Work Completion Certificate) issued to the bidder by clients must be submitted along with the technical part of the submitted bid. The minimum nos. of such documents to be furnished must be **02 (two) nos. during last 05 (five) years**. Without the above stated documents, the bidder's experience will not be acknowledged.

(E) SCOPE OF WORK:

Supply of 1) 3.3 KV, 400 mm2, Three Core, XLPE insulated, Armoured, Aluminum Cable and 2) Cold Shrinkable Indoor Termination Kit for PH-II power House of LTPS, APGCL, Maibella.

(F) TERMS & CONDITIONS:

The bidder must adhere to all the below mentioned clauses of this tender document and the tender must be submitted as per instructions given in clause **G** below, in the absence of which the submitted tender of the bidder may not be considered for evaluation at this end.

The clauses under the head-'Terms & Conditions' are given below:

1. <u>Firm Price</u>: The basic price(s) quoted by the bidder shall be firm without any variation in any way till completion of the work (supply) in full. The bidder must state all the taxes & duties, freight, insurance, etc., as applicable, clearly in the Price-Bid of the submitted tender.



a) Terms of Payment:

- b) 100% payment including all taxes and duties shall be made after successful completion of the entire work (i.e., supply of cable and Termination Kit) in full & good condition at LTPS site and subjected to fulfillment of Performance Bank Guarantee Clause of this tender.
- c) The bidder shall submit the bill in quadruplicate for payment.
- d) Price quoted shall be LTPS basis.

2. Guarantee:

The material(s) supplied shall be guaranteed for a period of 12 months from the date of installation or 18 months from the date of receipt whichever is earlier. Free replacement of the material(s) shall have to be made for any defect/improper functioning that may develop under normal use during the guarantee period. The free replacement should be made within a reasonable time period as determined and directed by the Undersigned.

3. Delivery Period:

The delivery period is **90 days** from the date of issue of formal purchase order. The material(s) shall be delivered at LTPS site. Liquidated damage due to delay in delivery shall be levied as per the Liquidated Damage Clause of this tender.

4. Performance Bank Guarantee:

On receipt of the formal Order, the successful bidder shall have to furnish a Performance Bank Guarantee from Nationalized Bank/ Scheduled Bank of RBI for an amount equivalent to 10% of the total order value including taxes and duties before releasing payment. The BG shall be released after expiry of the Guarantee period as mentioned in Clause 'F2'.

5. Liquidated Damage:

In case of delay in supply of ordered materials beyond the delivery period as mentioned in clause 'F3', a penalty @1% (one percent) of the total value of the undelivered materials or materials delivered late per week delay subjected to maximum of 10% (ten percent) of the total value of the undelivered material will be imposed upon the Contractor. This is, however, subject to Force Majeure clause as given in "General Condition for Supply & Erection of APGCL". The payment of liquidated damage shall not in any way relieve the Contractor from any of its obligation to complete the supply work or from any other obligation and liabilities of the Contractor under the Contract.

6. Validity of the Offer:

The Offer shall be valid for a period of 120 (one hundred twenty days) from the date of opening of the technical bid.

7. Insurance:

Insurance of the supplied material(s) shall be done by the Contractor on APGCL's behalf and payment shall be made at actual on submission of documentary evidence along with the payment for the supply part.

8. Testing & Inspection:

The cables are required to be tested as per IS specification and in presence of APGCL's authorized personnel. The Contractor will inform LTPS, APGCL about the readiness of such inspection, at least 10 days ahead for deputing personnel from APGCL end. Dispatch clearance shall be accorded only after satisfactory testing of the materials. Further, the Contractor shall submit ISI certificate against the supplied cables and the cables must be marked with ISI certification mark.

- 9. <u>Technical literature/catalogue:</u> Technical literature/catalogue of the cables and termination kits is to be submitted at the time of delivery of material at LTPS site.
- 10. Marking of the Product: Manufacturer's identification mark, batch no. and year of manufacturer must be inscribed on the cables at least at every 05 meters of length.

11. Type Test Certificate:

The Contractor will be required to furnish Type Test Report for the supplied cables from any Government Approved Test House/Laboratory as per IS norms at the time of delivery of material at LTPS site.

12. Standard Drum Length: The cables have to dispatch in single drum.

13. Mandatory documents:

The bidder must furnish the following mentioned documents along with the technical part of the submitted tender without which the submitted tender may not be considered for evaluation at this end:

- a. Signed & sealed copy of LTPS, APGCL Tender Document.
- b. Copy of PAN Card.
- c. Copy of valid GST Registration Certificate of the bidder's Firm.
- Documents related to bidder's eligibility and past experience as per clauses C & D of this document.
- e. Documents related to bidder's Firm: Certificate of registration of the Firm (in case of Solo Proprietor)/ Partnership Deed (in case of LLP)/ Certificate of Incorporation' together with Memorandum / Articles of Association (in case of Company), whichever is applicable.
- f. Any other document as sought in this tender.

14. Clarification and Additional Information:

During submitted bid's evaluation, APGCL may request bidder for any clarification on the submitted bid and/or documents related to the APGCL tender. Bidder shall submit the sought clarifications and/or document(s) within stipulated time period as determined by the undersigned. However, seeking clarification and document(s) during post-bid evaluation shall be on sole discretion of APGCL.

15. Earnest Money Deposit (EMD):

The bidder must submit the requisite EMD along with the technical bid. Bid received without requisite EMD will be rejected.

EMD of **Rs. 12,000/-** (Rupees twelve thousand only) in the shape of Demand Draft in original of any Nationalized Bank shall be submitted as Earnest Money, duly pledged in favour of the Asstt. General Manager (F&A), LTPS, APGCL. APGCL will refund the Earnest Money of the unsuccessful bidders directly to the bidders within a reasonable period of time without any interest. The EMD of the successful bidder shall be returned after submission of PBG (Performance Bank Guarantee) by the bidder.

16. OWNER'S RIGHT TO ACCEPT OR REJECT A BID:

APGCL reserves the right to accept a bid other than the lowest and to accept or reject any bid in whole or part, or to reject all bids with or without notice or reasons. Such decisions by APGCL shall bear no liability whatsoever consequence upon such decisions.

17. Award of Supply:

- a) The bidder whose bid is accepted by APGCL shall be issued Confirmed Order/Letter of Intent prior to expiry of bid validity. The bidder have to confirm his acceptance of the P.O. by return e-mail within 7 (seven) days from receipt of purchase order at his end.
- b) APGCL shall not be obliged to furnish any information / clarification / explanation to the unsuccessful bidders as regards of non-acceptance of their bids. Except for refund of EMD (without interest) to unsuccessful bidder, APGCL shall correspond only with the successful bidder.

18. Arbitration Clause:

All disputes or differences whatever so arising between the parties out of or relating to this Order shall be settled by arbitration as per clause 33.00 of "General Conditions for Supply and Erection of APGCL, 2014". The venue of arbitration shall be at Guwahati.

19. Other Terms: Any other terms & conditions not covered by above clauses shall be governed by "General Condition of Supply & Erection, 2014" of APGCL.

20. Jurisdiction:

Subject to arbitration clause, all questions, disputes of differences arising under out of or in connection with the contract shall be subject the exclusive jurisdiction of Courts of Guwahati.
