- 1) The vehicle should be Brand new or in Good condition. The vehicle shall be under the control of DGM(Civil), Lakwa Thermal Power Project, APGCL all throughout 24X7.
- 2) Earnest money of Rs. 5000/- (Rupees five thousand) only in the shape of Demand Draft in original of any Nationalized Bank in favour of Assistant General Manager (F&A), LTPS, APGCL, Maibella-785689, Dist-Charaideo, Assam is to be submitted along with the quotation.
- 3) Vehicle must be placed within 25 days from the date of issue of the order otherwise; the earnest money will be forfeited.
- 4) Model, seating capacity, etc should be specifically mention in the quotation.
- 5) Vehicle must have valid "Commercial" Registration from competent authority.
- 6) Vehicle must have 1st party insurance from the competent authority.
- 7) The supplier must have valid GST Registration No.
- 8) Pollution Clearance Certificate of the vehicle must be available.(For New Vehicle it is optional)
- 9) Experienced driver having valid Driving License of age group between 30-40 years with sound health is to be provided for driving the vehicle at the owner's/supplier's cost.
- 10) Vehicle must be station at Lakwa Thermal Power Project campus for 24 hours duty. The driver of the vehicle should be present during normal duty hours and should be available at call all throughout 24X7.
- 11) The hiring rate should be quoted on monthly basis and tax component (GST) should be shown clearly. In case tax component is not shown separately, it will be assumed that the offered rate is inclusive of all taxes. Copies of the GST Registration & PAN of the Supplier are to be submitted along with the quotation.
- 12) Department shall supply the fuel as per requisite by authorized body. Lubricants, mobile oil etc. are to be borne by the Owner/Supplier.
- 13) Vehicle maintenance, both minor and major, is on Owner's / Supplier's responsibility. Supplier shall provide substitute vehicle immediately in case the supplied vehicle is under repairing or not available due to other reasons. Hiring charge will be adjusted by calculating on double the hiring rate of daily basis in case of vehicle not found available.
- 14) Properly maintained car diary and logbooks by the supplier must be present in the vehicle wherein details of tour verified by the user/ authorized body is given.
